Part 1 (pursuant to section 120.74(1)(a), Florida Statutes)

Part 3 (s. 120.74(1)(c), Florida Statutes)

Section 120.74(1)(c), Florida Statutes states, in part:

The [annual regulatory] plan must include any desired update to the prior year's regulatory plan or supplement published pursuant to subsection (7).

Update(s) to Subparagraph (a)1 (Part I, Laws Enacted/Amended):

The Department of Correction's 2016-17 Annual Regulatory Plan did not list any laws pursuant to 120.74(1)(a), Florida Statutes, which required rulemaking. Therefore, an update under this provision is not applicable.

Update(s) to subsection (7) (Supplement to the Regulatory Plan):

The Department of Correction's 2016-17 Annual Regulatory Plan did not include any supplemental laws pursuant to 120.74(7), Florida Statutes, which required rulemaking. Therefore, an update under this provision is not applicable.

Rules 33-103.005, 33-103.006, 33-103.007, 33-103.008, 33-103.011, and 33-103.014: implementation during 2016-17 was temporarily postponed to further develop improved efficiency, clarify and improve coordination with other agencies the listed rules.
