

## FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for Department of Corrections Avon Park building damages due to Hurricane Irma (DR-4337-FL PW 07967 PN 32681). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 6, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Floodplain:** Project sites (5) are located in the A Zone, otherwise known as Special Flood Hazard Area (SFHA), per Highlands County FIRM Panel #12105C1000G dated 09/28/2012.
- Proposed Work and Purpose:** The Department of Corrections replaced roofing, an exhaust fan, paneling, sheet rock and baseboards on 5 building sites as a result of high winds and heavy rain from Hurricane Irma.
- Project Alternatives:** The alternative that has been considered is the no action alternative. This alternative is not feasible as the area will remain vulnerable to flood risk, including property damage and hazards to human life and safety. With the no action alternative, continued negative impacts on the community may be experienced. Alternate locations were not considered as relocating the facility is not a practical, cost effective alternative.
