WHEREAS, complaint under oath was presented before me, the undersigned Judge of this Court this date alleging that BRIAN KEITH BLACKSHEAR, in Bradford County, Florida, between August 1, 2016 and November 8, 2016, did corruptly give, offer, or promise to any public servant, any pecuniary or other benefit not authorized by law, with the intent or purpose to influence the performance of any act or omission which he believes to be, within the official discretion of a public servant, in violation of a public duty, or in performance of a public duty, contrary to Section 838.015, Florida Statutes. (L7)

COUNT II: AND WHEREAS, complaint under oath was presented before me, the undersigned Judge of this Court this date alleging that BRIAN KEITH BLACKSHEAR, in Bradford County, Florida, between August 1, 2016 and November 8, 2016, did corruptly give, offer, or promise to any public servant, any pecuniary or other benefit not authorized by law, with the intent or purpose to influence the performance of any act or omission which he believes to be, within the official discretion of a public servant, in violation of a public duty, or in performance of a public duty, contrary to Section 838.015, Florida Statutes. WHEREAS, the Court finds from the facts alleged in said complaint that there is probable cause that said offenses were committed and that said Defendant committed them.


