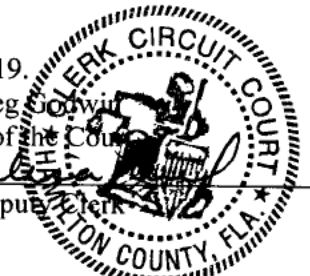

The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following Violation of the law On the 4th day of October 2019 at 7:23 AM PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector Chris McGauley with the Office of Inspector General for the Florida Department of Corrections, and the defendant is Deborah Gregory. Your affiant has investigated an Introduction of Contraband into a State Facility (*attempted*).

On October 04, 2019, your affiant responded to HCI (*Hamilton Correctional Institution*) after Deputy Pearsall Fouraker (*Deputy Fouraker*) detained Chadd Petrik (*Petrik*) (*Former Inmate*) in the wooded area on FDC property, outside of the secured perimeter of HCI, with four (4) grass camouflaged packages, contained cell phones, and candy. This inspector subsequently arrested Petrik for attempting to introduce contraband into the secure perimeter at HCI. During Deputy Fouraker's detention of Petrik, he told Deputy Fouraker, post Miranda, he was dropped off in the wooded area by Victoria Saunders (*Saunders*) his girlfriend, and the co-defendant, Deborah Gregory (*Gregory*) (*Petrik's friend*).

Simultaneously, while Deputy Fouraker was detaining Petrik, Deputy Sam McDonald (*Deputy McDonald*) received a call there was a suspicious vehicle (*silver van, Tag# EXHU28 FL*) in a driveway on Highway US 41 North (*approximately 2 miles away from HCI*) with its lights off. Once Deputy McDonald contacted the occupants of the vehicle, it was determined the occupants were Saunders (*passenger*) and Gregory (*driver*). The two indicated they drove from Tampa, were lost, and were looking for a friend's house in Jasper, FL. Deputy McDonald gave Gregory and Saunders instructions to the Budget Inn motel after Gregory inquired of the nearest motel.

Your affiant, Senior Inspector Lee McGauley (*SI McGauley*) and Inspector Brittany Jordan (*Inspector Jordan*) located Gregory and Saunders at the Budget Inn Motel. Both individuals were interviewed post Miranda concerning the above incident. Gregory and Saunders both testified similarly that they transported Petrik (*who gave them directions to Jasper, FL*) from Port Richie to Jasper, then dropped him off on Highway 249 in a heavily wooded area. They admitted there was no friend in Jasper they were looking for, which is what they told Deputy McDonald. After a brief stay at the motel they were planning on heading back to Port Richie, FL. Gregory would not allow a thorough search of the van; however, allowed inspectors to visually look into the van. Your affiant observed a blade of grass (*like the grass Petrik used on the contraband packaging to attempt to camouflage it*) in the front passenger floor board. Gregory retrieved a black book bag from the van, which contained Petrik's wallet. The black book bag was given to Hamilton County Sheriff's Deputies to be put with Petrik's property in jail.

The blade of grass in the front passenger floor board, coupled with Petrik's wallet being located inside the van provides proof Petrik was inside the van confirming Gregory's statement she drove him and dropped him off. Due to the size of the package Petrik was carrying with the contraband and the fact he was dropped off during non-visiting hours in a location which prudent individuals would find suspicious, it is reasonable to believe Gregory and Saunders knew what Petrik was planning on doing.


A search of Florida Department of Corrections (*FDOC*) information database confirmed Gregory has been incarcerated before for drug offenses and released from FDOC February 28, 2015.

A search of Florida Department of Corrections (*FDOC*) information database confirmed Saunders has been incarcerated before for drug offenses and released from FDOC July 2, 2015.

Your Affiant respectfully submits probable cause has been established indicating Victoria Saunders did commit the violation of one (1) count; Principal in the First Degree (*attempted, Introduction of Contraband, 12 cell phones*) in violation of FSS 777.011 / 944.47(1)(a)6, and one (1) count; Principal in the First Degree (*attempted Introduction of Contraband, 6 assorted food items, not approved*) in violation of FSS 777.011 / 944.47 (1)(a)2, in Hamilton County, Hamilton Correctional Institution on October 4, 2019, by aiding Chadd Petrik in attempting to Introduce Contraband (*cell phones and food items not approved*) into the secured perimeter of Hamilton Correctional Institution.

Your Affiant respectfully requests a warrant be issued for Victoria Saunders for one (1) count; Principal in the First Degree (*Introduction of Contraband, cell phones*) in violation of FSS 777.011 / 944.47(1)(a)6, and one (1) count; Principal in the First Degree (*Introduction of Contraband, assorted food items not approved*) in violation of FSS 777.011 / 944.47 (1)(a)2.

All supporting documents will be available for judicial review and will be further explained in your affiant's report of investigation.
