84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector Stacy L. Harris with the Florida Department of Corrections, Office of the Inspector General. Your Affiant has probable cause to believe that between December 23, 2019 and December 28, 2019, at Santa Rosa Correctional Institution - Annex, 5850 E. Milton Road, Milton, Santa Rosa County, Florida, former Correctional Officer Jana Wood, did commit the criminal offense of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47(1)(a)(1) Fla. Stat., when Officer Wood did actually and intentionally transmit digitally written, hand written and recorded communications into the secure perimeter of a State Correctional Institution to an Inmate. Further, Officer Wood did commit the criminal offense of Unlawful Use of a Two-Way Communications Device in violation of s. 934.215 Fla. Stat., when Officer Wood did actually and intentionally utilize a cellular telephone to transmit digitally written and recorded communications to the contraband cellular device seized during a mass search on February 3, 2020 from M – Dormitory, a secured housing unit within the secure perimeter of a State Correctional Institution.

On February 3, 2020 a mass search of secured housing unit M – Dormitory was conducted by K9 Captain Daniel Carmical, Florida Department of Corrections. Captain Carmical discovered two cellular telephones, wrapped in cellophane, in the mop closet of the Wing 1 bathroom of M – Dormitory. One cellular device was an Alcatel smartphone and one cellular device was a black, LG smartphone. Between the two cellular telephones was the identification card of Inmate Joseph Evans, DC #U22090. The cellular devices were sent to the Florida Department of Corrections, Office of the Inspector General's cellular telephone laboratory for analysis. On March 3, 2020 a Cellbrite Extraction report was generated of the information contained in the Alcatel smartphone, IMEI #01502600385911, and SIM Card #89014103270784591893, which revealed text message communications between the contraband cellular device and the telephone number [REDACTED] which was identified as the personal contact cellular telephone of Correctional Officer Jana Wood, as provided by Officer Wood and confirmed by investigative sources.

Call logs from the extraction report indicated the following text message exchanges:

On 12/23/2019, at 10:08 a.m., a text message to Officer Wood's number read: "This is Davey are you still up"

On 12/24/2019, 6:46 a.m., a text message to Officer Wood's number read: "What's up my green eyed girl u going to talk to me or what"

On 12/24/2019, at 00:48 a.m., a text message from Officer Wood's number read: "Whats up"

On 12/24/2019, at 00:49 a.m., a text to Officer Wood's number read: "U up I'm trying to talk to you"

On 12/24/2019, at 00:50 a.m., a text from Officer Wood's number read: "Im headed back to the prison from [REDACTED]"

On 12/24/2019, at 00:51 a.m., a text to Officer Wood's number read: "Damn I'ma call u later if u up when you get off text me"

On 12/24/2019, at 00:52 a.m., a text from Officer Wood's number read: "Okay all I gotta do is turn in my gun then im headed home"

On 12/24/2019, at 00:54 a.m., a text to Officer Wood's number read: "Ok I'ma call u later if I get a chance my beautiful green eyed woman"

On 12/24/2019, at 00:56 a.m., a text from Officer Wood's number read: "Ok"

On 12/24/2019, at 1:11 a.m., a text from Officer Wood's number read: "Okay im in the car headed home"

On 12/28/2019, at 9:35 p.m., a text to Officer Wood's number read: "Hey babe, pretty green eyed lady you know I want to kiss you and have sex"

Officer Wood's timecard at Santa Rosa Correctional Institution indicated she worked on 12/23/2019 from 3:18 p.m. to 1:08 a.m. on 12/24/2019 and on 12/24/2019 from 6:18 p.m. to 1:28 a.m. on 12/25/2019.

Attempts to have Officer Wood contact Your Affiant went unanswered and no statement was able to be obtained from the defendant. However, on February 11, 2020 during a meeting with Warden Marvin W. Clemmons, Officer Wood submitted an incident report in which she admitted to writing a note to Inmate Lavaros Davis, DC #M63150, which was found by Lieutenant Timothy Lingo on February 8, 2020 on the person of Inmate Davis. In sworn witness testimony from Lieutenant Lingo, he indicated he observed papers in the hand of Inmate Davis on February 8, 2020 during [REDACTED]. When Inmate Davis relinquished the papers, Lieutenant Lingo discovered a note which read, "Your arms are long enough to wrap around me legs and hold me down. I've been

told I have a tight like a virgin. I have an alias Brittany Cloud." Lieutenant Lingo found a Facebook page with the name Brittany Cloud and a photograph which closely resembled Officer Wood. Further, on two separate pieces of paper was written the known telephone number and home address (listed above) of Officer Wood.

In sworn witness testimony from Warden Clemmons on March 20, 2020, he indicated he asked Officer Wood about the alias name of Brittany Cloud, which Officer Wood admitted was her alias while denying the Facebook page was hers. Officer Wood submitted an incident report regarding the note she wrote to Inmate Davis in which she admitted to having provided the notes to Inmate Davis.

In sworn witness testimony from Major Nicholas Rushing on March 23, 2020, he indicated he was present with Warden Clemmons at the time he met with Officer Wood and heard Officer Wood admit to having provided the notes to Inmate Davis; however, Officer Wood denied any type of physical contact with Inmate Davis. Major Rushing was present when Officer Wood wrote her incident report in which she admitted to providing the notes to Inmate Davis and then Officer Wood immediately tendered her resignation.

Your Affiant respectfully submits probable cause has been established to conclude Officer Jana Wood did commit the criminal violation of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47(1)(a)(1) Florida Statute, when Officer Wood did actually and intentionally transmit digitally written, and written and recorded communications into the secure perimeter of a State Correctional Institution to a contraband cellular device discovered inside the secure perimeter of a State Correctional Institution. Your Affiant further submits probable cause has been established Officer Wood did commit the criminal violation of Unlawful Use of a Two-Way Communications Device, in violation of s. 934.215 Florida Statute when Officer Wood did actually and intentionally utilize a cellular telephone to unlawfully transmit digitally written and recorded communications to an inmate who was housed within the secure perimeter of a State Correctional Institution.
