Your Affiant is Law Enforcement Senior Inspector Lee McGauley of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe that between the dates of May 1, 2020, through August 12, 2020, FDC Correctional Officer Reagan Hope Wilds (*CO Wilds*), did commit the crimes of; one count of Official Misconduct F.S.S. 838.016 (1), twelve counts of Introduction or possession of certain articles unlawful written or recorded communication or currency F.S.S. 944.47(1)(a)1 while acting in her official capacity as a Correctional Officer at the New River Correctional Institution.

Based on information received, this Inspector reviewed the JPAY messages sent from Amila Amhard (*fictitious name*), to three separate inmates currently incarcerated within the Florida Department of Corrections (FDC) and housed at New River Correctional Institution (*NRCI*). The message sent by Amhard began on May 1, 2020, and continued until August 12, 2020. The account was determined to have been created by CO Wilds, who utilized the name Amila Amhard to conceal her identity, Reagan Hope Wilds who is currently employed as a Correctional Officer by FDC and assigned to NRCI. The account of Amhard contained the actual date of birth and home address of CO Wilds that was verified with FDC database records. Further investigation revealed CO Wilds linked her personal debit/credit card to the account for the purpose of providing monetary benefits to the inmate(s).

There are numerous incoming messages (80) from CO Wilds to the inmate(s), however the counts were narrowed to the most serious communications (12 counts). CO Wilds documented in the messages that she is currently in class and the inmate can call her after 6:30pm when she gets off work. She explains she is willing to accept the marriage proposal of one of the inmates and wanted the inmate to ask her in person and not on JPAY. CO Wilds messaged an inmate about being excited to see him once inmate visitation is back open. Another message from one of the inmates involved messaged CO Wilds can't wait to touch her again. CO Wilds indicated she was using another person's cell phone and the inmate would have to call her between the hours of 6:30pm to 12am. This statement is indicative of the inmate possessing and using a contraband illegal cell phone while incarcerated in prison. A review of the inmates secures account revealed he has only spoken to one person, which is his brother while being housed at NRCI. On August 17, 2020, Bradford County State Attorney's Division Chief Bustamante reviewed the facts of this case with Lead Senior Inspector Lee McGauley and agreed with the charges on this Probable Cause Affidavit.

In a post Miranda sworn recorded interview conducted on August 17, 2020, with CO Wilds at the Florida State Prison Region 2 Training building.

 CO Wilds explained two inmates propositioned her to have sexual relations, but denied having sexual relations.

Your affiant respectfully submits that probable cause has been established that CO Wilds, Reagan did commit the criminal offense of 12 Counts - Introduction or possession of certain articles unlawful written or recorded communication or currency F.S.S. 944.47 (1)(a)1 and Official Misconduct F.S.S 838.016 (1).
