Your affiant is Law Enforcement Inspector Keith D. Turner of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe that on January 16, 2020, at approximately 4:01 PM, Inmate Jakeliah Weeks DC# 156808 (*Inmate Weeks*) did commit the criminal offense of Battery Upon a Law Enforcement Officer when she physically attacked [REDACTED] at the Florida Women's Reception Center, by grabbing her by the hair and pulling [REDACTED] onto the floor in violation of s. 784.07 Fla. Stat., which states that whenever any person is charged with knowingly committing a battery upon an employee or agent of the Department of Corrections who supervises or provides services to inmates, the offense shall be reclassified as a felony of the third degree.

In an Incident Report submitted on January 16, 2020, Victim [REDACTED] reported that after speaking to Inmate Weeks [REDACTED] in A-Dormitory, Inmate Weeks stood up, grabbed her ([REDACTED] upper torso and hair, and pulled her to the floor. [REDACTED] then observed Correctional Officers Christopher Durden (*Officer Durden*), Danyelle Sappleton (*Officer Sappleton*), Danielle Gerhing (*Officer Gerhing*) and Courtney Schweinsberg (*Officer Schweinsberg*) respond and use reactionary force to stop Inmate Weeks from assaulting her. Once Inmate Weeks' grasp was released, [REDACTED] departed the area.

In an Incident Report submitted on January 16, 2020, Officer Gehring reported while assigned as A-Dormitory escort officer, she observed [REDACTED] attempting to exit [REDACTED] when Inmate Weeks ran towards the door. Inmate Weeks slammed into [REDACTED] and grabbed her ([REDACTED]). Officer Durden grabbed Inmate Weeks and redirected her to the floor as Officer Camargo tried to release Inmate Weeks' grip of [REDACTED] hair. Officer Gehring then pulled [REDACTED] by her legs to a safe area away from Inmate Weeks. Officer Gehring returned and placed leg restraints on Inmate Weeks while Officer Schweinsberg held Inmate Weeks' legs. Inmate Weeks was then escorted away from the area.

In an Incident Report submitted on January 16, 2020, Officer Durden reported while assigned as A-Dormitory escort officer, he observed Inmate Weeks and [REDACTED] talking. As [REDACTED] began to exit [REDACTED] Inmate Weeks ran and grabbed [REDACTED] by her sweater. Officer Durden then grabbed Inmate Weeks and redirected her (*Weeks*) to the floor, placing her in the prone position. Officer Durden continued to hold Inmate Weeks down until leg restraints could be placed on her. Subsequently, Inmate Weeks was escorted away from the area.

In an Incident Report submitted on January 16, 2020, Officer Sappleton reported while assigned as A-Dormitory housing officer, she observed Inmate Weeks grab [REDACTED] by her sweater. As Officer Sappleton was responding, she observed Officer Durden grab Inmate Weeks and place her on the floor. When Officer Sappleton arrived, she grabbed Inmate Weeks' arms and attempted to release Inmate Weeks' grasp of [REDACTED] hair. She held Inmate Weeks's down until she was instructed to release her grasp.

In an Incident Report submitted on January 16, 2020, Officer Schweinsberg reported while assigned as A-Dormitory housing officer, she heard yelling coming from [REDACTED]. As she was on the way to the area, she observed Officer Durden respond [REDACTED]. When she arrived, she observed Inmate Weeks, Officer Durden, Officer Camargo, Officer Sappleton and [REDACTED] on the floor. Officer Schweinsberg then grabbed Inmate Weeks' legs and immobilized them until Inmate Weeks was under control. Inmate Weeks was then escorted out [REDACTED].

The fixed wing video recording was reviewed, and according to the time stamp of the video, the following information was observed:

At approximately 4:01 PM, while inside [REDACTED] A-Dormitory, [REDACTED] stood up from a sitting position and approached the door leading out to the open bay area of the housing unit. Subsequently, Inmate Weeks stood up and charged at [REDACTED] grabbed her ([REDACTED] hair, and forcefully pulled her down onto the floor. Several security staff members responded and restrained Inmate Weeks, while a correctional officer grabbed [REDACTED] by the legs and pulled her away from Inmate Weeks' grasp. Security Staff could be heard ordering Inmate Weeks to release [REDACTED].

Victim [REDACTED] from January 16, 2020 reflects that [REDACTED].

Photographs taken by security on January 16, 2020 depict the findings of the [REDACTED]

During a sworn recorded interview conducted on January 29, 2020, [REDACTED]

Several security staff members responded and used force on Inmate Weeks to stop the attack against [REDACTED] wished to pursue criminal charges against Inmate Weeks for the unprovoked battery that [REDACTED]

Note: The recorded interview contains Personal Health Information pertaining to Suspect Inmate Weeks.

In a December 9, 2020, post-Miranda recorded interview, Inmate Weeks invoked her right to counsel and declined to make a statement.

Your Affiant respectfully submits that probable cause has been established, that Inmate Weeks did commit the criminal offense of Battery Upon a Law Enforcement Officer when she physically attacked [REDACTED] by grabbing her by the hair and pulling her onto the floor, in violation of s. 784.07, Fla. Stat. in Marion County, while at Florida Women's Reception Center, 3700 NW 111th Place, Ocala, Florida 34482.
