84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant, Inspector Latricia Ruiz, is a sworn law enforcement officer with the Office of the Inspector General, Florida Department of Corrections.

On December 16, 2020, at Hardee Correctional Institution Work Camp, Bowling Green, Florida, Hardee County, the above-named defendant, Inmate Darris Washington born 12/25/1979, did violate Florida State Statute, committing the criminal offense of: Introduction and possession of unlawful articles in a correctional facility; by knowingly and intentionally possessing/introducing a suspected controlled substance of MDMA (Methylenedioxy-Methamphetamine) - (a nonprescription drug having a hypnotic effect) within Hardee Correctional Institution- Work Camp (1 Count) (F.S.S. 944.47(1)(a)(4)). The defendant, Washington, had in his possession, concealed within his waistline of his state issue blue pants, 12 grams of MDMA inside Hardee Correctional Institution Work Camp (C.I.)., where Washington was housed as an inmate. (Washington's job assignment was as a Dormitory Houseman).

944.47 Introduction, removal, or possession of certain articles unlawful; penalty. —
(1)(a) Except through regular channels as authorized by the officer in charge of the correctional institution, it is unlawful to introduce into or upon the grounds of any state correctional institution, or to take or attempt to take or send or attempt to send therefrom, any of the following articles which are hereby declared to be contraband for the purposes of this section, to wit:
4. Any controlled substance as defined in s. 893.02(4) or any prescription or nonprescription drug having a hypnotic, stimulating, or depressing effect.

On December 16, 2020, Inmate Darris Washington DC# T14093 was observed picking up a clear bag from the floor in front of Alpha Dormitory, wing 1 side door at the work camp. Washington was then observed placing the clear bag into his waistline of his state blue pants. When Officer Ricardo Ramon confronted Washington, Washington was seen trying to discard the item into the grass by expelling the item through the bottom of his right pant leg. The clear bag was immediately recovered from the grass area by Officer Ramon. Upon further inspection of the bag, the bag contained a large amount of white powdery substance. The substance was tested using the Marquis Reagent test kit and tested positive for MDMA (Molly). The powder weighed approximately 12 grams.

In his sworn digitally recorded statement, Correctional Officer Ricardo Ramos indicated the following: He is a uniformed correctional officer assigned to Hardee Correctional Institution. He was assigned as the training officer at the work camp on December 16, 2020. He was standing outside by the staff canteen, when he observed Inmate Washington approach the A-1 side of Alpha dormitory and retrieve an item from the floor. The item was in plain sight along the side of the building. As Washington retrieved the item, he immediately placed the item in his waistband, which immediately caught his attention. At that point, he called Washington over to conduct a pat search. He then called the shift supervisor, whom was standing in front of the chow hall to observe the incident. As Inmate Washington approached, he and Lt. Edward Kilgore observed Washington kicking his leg to the side attempting to discarded the item through his pant leg and observed the item drop from Washington pant leg. The clear bag was immediately recovered from the grass which contained a white powdery substance in rock form. Washington was subsequently taken into custody.

In his sworn digitally recorded statement, Correctional Officer Lieutenant Edward Kilgore the following: He is a uniformed Correctional Officer Lieutenant assigned to Hardee Correctional Institution Work Camp. He and Officer Ramos were standing by the Shift supervisor office, when they observed Inmate Washington walking down the sidewalk, acting suspicious. At that point, Officer Ramos called Washington over to them. Washington began to fidget with his pants as he walked towards Ramos and himself. Washington then began shaking his pant leg in which they both observed an item fall to the ground from the inmate's pant leg. The item was recovered and subsequently firld tested which yielded a presumptive positive for MDMA "Molly".

Inmate Washington, declined an interview and has an end of sentence of April 1, 2021.

In summary, the defendant, Darris Washington, did knowingly and intentionally possess/introduce a controlled substance in the form of MDMA-Methylenedioxy- Methamphetamine (Identifed via Marquis Reagent testing kit), concealed inside of his waistband, then later discarded to the ground upon questioning, within the Hardee Correctional Institution- Work Camp, violating 1 count of Florida State Statute 944.47 (1)(a)(4) Introduction and possession of unlawful articles.
