Your Affiant is Inspector Gregory Elias with the Office of Inspector General (O/G) for the Florida Department of Corrections (FDC). The defendant is Sergeant Michael Clark Daniels (Sergeant Daniels), who is currently a certified FDC Correctional Employee assigned at Franklin Correctional Institution (FCI). Your affiant has investigated Introduction of Contraband case (text messages via Cellular Phone Device), where Inmate alleged Sergeant Daniels was conspiring with inmates to introduce contraband into the secure perimeter at FCI.

alleged that Sergeant Daniels had conspired with several inmates to introduce contraband into the facility at FCI; therefore, he was interviewed and noted the following: He observed Sergeant Daniels go into Inmate Albert Thompson's (Inmate Thompson) DC# X29766, assigned cell on several occasions occurring on unknown dates and times. He overheard Inmate Thompson having a conversation (conspiring to introduce contraband) with an individual named "Daniels" on a contraband cellular device. He observed Inmate Thompson and Sergeant Daniels have lengthy conversations at cell front but did not overhear what the conversations pertained to. He never observed Inmate Thompson receive any contraband (marijuana, cigarettes, meth, cocaine, cellular devices) from Sergeant Daniels. He had no knowledge of a Cash App names being used for any payment sent to Sergeant Daniels.

On September 18, 2020, security staff at FCI conducted a routine search of 8-dormitory, Inmate Thompson were housed and discovered Inmate Denard Hall (Inmate Hall) DC# M62928 to be in possession of a Cellular Device, which was later submitted to the Office of the Inspector
