Your Affiant is Senior Inspector Scott Gambel (*Inspector* Gambel) with the Office of Inspector General for the Florida Department of Corrections. The Defendant is Sergeant Matthew Spivey (*Sergeant Spivey*) who was assigned to Suwannee Correctional Institution. Your Affiant has conducted an investigation into the Possession/Introduction of Contraband.

On August 10, 2021, Sergeant Spivey was reporting for duty at Suwannee Correctional Institution. Sergeant Spivey entered the control room and was subjected to a random pat search by Sergeant John Greene (Sergeant Greene). During the pat search, Sergeant Greene located 3 capsules of an unknown substance in the right hip pocket of Sergeant Spivey. The capsules were wrapped in plastic and contained a white crystal substance. Sergeant Spivey admitted the substance inside the capsules was Methamphetamine.

The substance inside the capsules was field tested by Inspector Gambel, using a Methamphetamine test kit which showed a positive result.
