They were Inmate Ja'Meisha Wallace DC #V80925 in cell While they were at cell front, Inmate Wallace retrieved a cup of urine from inside the cell and threw it on Officer and The urine struck Officer in the face and on the arm.

	This incident was captured on the LCI Annex closed circuit video system and what was viewed was consistent with the reports and statements provided by Officer and and On June 25, 2021, Inmate Wallace was read Miranda warning from a department issued Miranda rights waiver form. Inmate Wallace indicated she understood her rights and refused to provide a sworn recorded statement without legal counsel.
