

84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector Troy Brady, of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe Kadaen Scott, Former Officer at Walton Correctional Institution, did commit the criminal offense of Introduction, removal, or possession of contraband in violation of FS 944.47(1)(b) by introducing tobacco products into Walton Correctional Institution.

On August 13, 2020, Inspector Brady conducted a post Miranda, sworn, recorded interview of Officer Scott at Walton Correctional Institution which included the following information:

Officer Scott has been working for the Department of Corrections for approximately 11 months.

Photograph Review

The below listed photographs were taken upon Officer Scott allowing his phone to be viewed and photographed, showing contact with the phone numbers provided during the interview.

Photograph #1- This picture shows numbers which have been blocked by Officer Scott on his phone. Phone number 1(561) 543-7399 was identified as Inmate Petit's contraband cell phone used to contact Officer Scott.

Photograph #2- This picture shows the blocked number 1(561) 543-7399 on Officer Scott's phone

Photograph #3- This picture shows messages sent to Officer Scott from Inmate Petit, who is using the contraband phone to advise Officer Scott what items to purchase and the agreed price per pack of cigarettes. The message is time stamped for Wednesday, August 5, 2020, at 00:09 hours.

Photograph #4- This picture shows more messages sent to Officer Scott from Inmate Petit, who is requesting the cigarettes be brought in that weekend and requesting Officer Scott make a Cash-App tag so the payment for the cigarettes can be sent. There is no time stamp due to the message being sent at approximately the same time and date as the previous picture.

Photograph #5- This picture shows more message sent to Officer Scott from Inmate Petit. The messages are dated Wednesday, August 5, 2020, at 12:44 hours, and Thursday August 6, 2020, at 15:18 hours.

Photograph #6- This picture shows a contact page for "Jaquan" on Officers Scott's phone. "Jaquan" is former Officer Ja-Qwan Martin who is a personal friend of Officer Scott's. Ja-Qwan's phone number is [REDACTED] The contact card shows last contact which was August 12, 2020, at 17:22 hours. The outgoing call from Officer Scott's phone lasted five minutes.

Photograph #7- This picture shows Officer Scott's Apple Pay app which shows a deposit from apply cash for \$120.00 on August 11, 2020.

Photography #8- This pictures shows the transaction details of the Apple Pay deposit which was posted on Tuesday, August 11, 2020.

On August 14, 2020, Inspector Brady conducted a search of Inmate Petit's property during which multiple phone numbers and Cash-App names were written on miscellaneous pieces of paper and inside a Bible which were confiscated and entered into evidence. The following list will provide a description of each piece of evidence collected.

Evidence #1- Department of Corrections face sheet for Inmate Sylvester Joseph DC# L74601

Evidence #2-8 - Miscellaneous papers which have what appears to be Cash-App tags and phone numbers.

Evidence #9 - torn paper with Cash-App tag "\$yayahhhhh" written on it.

Evidence #10- JPAY account statement for Inmate Petit.

Evidence #11-13 - Bible pages with multiple phone numbers and Cash-App tags printed throughout.

On August 27, 2020, Inspector Brady conducted a sword recorded interview with Officer Barrett who provided the following information:

Officer Barrett offered to go to B-dormitory to aid Officer Scott with count. Upon arrival Officer Barrett noticed Officer Scott talking through the flap to an Inmate identified by Officer Barrett as Inmate Richard Petit. Officer Barrett overheard some of the conversation which included discussion about bringing in cigarettes. Inmate Petit began discussing the introduction of contraband with Officer Barrett and explained how much money could be made which was approximately 300 dollars for every pack of cigarettes. Officer Barrett instructed Inmate Petit to leave multiple times and refused to participate in the discussion. Officer Barrett then reported this incident to supervisor, completed an incident report and discussed the incident with Captain Carranza.

Your Affiant has probable cause to believe Kadaen Scott, Officer at Walton Correctional Institution, did commit the criminal offense of Introduction, removal, or possession of contraband in violation of FS 944.47(1)(b) by introducing tobacco products into Walton Correctional Institution and respectfully requests a capias be issued for Kadaen Scott, W/M, DOB [REDACTED]
