The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law:
On the 2nd day of January 2022 at 06:10 AM PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector Lorraine Fair with the Office of Inspector General for the Florida Department of Corrections (FDC) and the defendant is Sleter Nerette. Your Affiant has investigated twenty (20) counts of Conspiracy to Introduce Contraband (18 cellular phones, 45 grams of tobacco and 28 grams of synthetic marijuana-K2), one (1) count of possession of marijuana (5 grams) and one (1) count of firearm by convicted felon.

On January 2, 2022, at Hamilton Correctional Institution (HCI), Sergeant Hermisha Waddell (Sgt. Waddell) noticed headlights behind the warehouse, which is on the grounds of the Institution. Upon investigation, a white, 2018 Mercedes-Benz four door sedan was located mired in the soft sand of the fire-line with the defendants, Olrich Joseph (Joseph) and Sleter Nerette (Nerette) inside the car in the driver's and front passenger seat. Hamilton County Sheriff's Office (HCSO) responded and, upon approaching the vehicle, saw suspected marijuana in plain view in the back seat of the car. Joseph and Nerette were detained. The packaged weight of the marijuana located in the backseat was 5 grams. A subsequent search of the immediate area surrounding the car was made. A backpack was located approximately 5 feet from the car. Inside were packages wrapped in camouflage duct tape. Matching duct tape was located in the car. Concealed in the duct taped packages were the cell phones, tobacco and K2. Within a foot of the backpack another duct taped package was located, as well as a SCCY 9-millimeter handgun with eight (8) rounds of 9 mm ammunition (serial # 49477).



Joseph and Nerette are both convicted felons.

Your Affiant respectfully submits probable cause has been established that Joseph and Nerette did commit the violations of twenty (20) counts of Conspiracy to Introduce Contraband in violation of FSS 777.04 (3)/944.47, one count of

Possession of less than 20 grams of Marijuana in violation of FSS 893.13 and Possession of a Firearm by Convicted Felon in violation of FSS 790.23

All supporting documents referred to in this Affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.

Nerette was taken into custody by HCSO Deputies P.J. Fouraker and Benji Burnham.
