

ON 08/14/2022 at approximately 1602 hours, I responded to Polk Correctional Institute located at 10800 Evans Rd. Polk City, Fl. Upon arrival I made contact with Inspector Luis Fernandez with the Florida Department of Corrections, Office of Inspector General ID# 145650 and he stated the following

"I was working a Contraband Interdiction Unit (CIU) detail on the above date and time at Polk Correctional Institution. I was informed that a female, identified later as Jessica P. Bailey (Ms. Bailey) via North Carolina Driver License, had contraband inside her vagina after she entered the secured compound at Polk CI for visitation.

I conducted a sworn interview with Briana Davis (Officer Davis), Senior Probation Officer who is also dual certified as Correction Officer. Officer Davis advised the following via recorded sworn statement; At approximately 10:44 am, she was assigned to the front desk for female visitor searches. Visitor Jessica Bailey went into the search room and while conducting a search of Ms. Bailey, Senior Probation Officer Briana Davis went all the way up between Ms. Bailey's leg and felt a hard object. Officer Davis stated Ms. Bailey advised that it was a tampon and got very nervous. After Officer Davis asked again if she was hiding something, Ms. Bailey

Ms. Bailey then pulled the object out of between her legs and handed it to Officer Davis. Officer Davis secured the object and called the Officer In Charge (OIC) Captain Cody Finley who then called me.



I observed a plastic bag containing loose tobacco leaves and inside the tobacco leaves, I observed another plastic bag containing what appeared to be Cannabis. Captain Christopher Clifton from the CIU unit was present and assisted by testing the green leafy substance which yielded a positive result for Cannabis.

The package was examined and contained a green leafy substance. The substance weighed 8.9 grams and field tested positive for Cannabis.

Your Affiant respectfully submits probable cause has been established that the Defendant, Jessica Bailey, did in the County of Polk, and the State of Florida, commit the criminal offense of Introduction of Contraband into a State Correctional Institution, in violation of F.S. 944.47(1)(a)(4), and Possession of Cannabis which is in violation of F.S. 893.13(6)(b)."

Based on Inspector Louis Statements I placed Bailey under arrest and transported her to the Sheriff's processing Center without incident.
