
During a recorded sworn interview, [REDACTED]

The fixed-wing video [REDACTED] at WCIMU, from September 11, 2022, captured Inmate Watson hit [REDACTED] across the back with a broom then grab [REDACTED] from the back, wrapping his arm around [REDACTED] chest and throwing him to ground where he bit [REDACTED] on the back [REDACTED]

Inmate Watson refused to provide a statement.

Your Affiant respectfully submits probable cause has been established that Inmate Thavellian Watson did commit the violation of one count, Aggravated Battery on a Law Enforcement Officer in violation of Florida State Statute 784.07(1)(d)(2)(d) in Wakulla County, Florida, Wakulla Correctional Institution Main Unit on September 11, 2022.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
