84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Inspector Steven Lee of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe Correctional Officer Ashante Sharice Patrick, did commit the criminal offense of Introduction of Contraband into a state institution, to wit-controlled substance in violation of FS 944.47(1)(a)(4) as well as Felony Possession of a Controlled Substance (Cannabis) 893.13(2) by concealing marijuana into a package and introducing this package into Northwest Florida Reception Center located in Washington County, FL.

On September 4, 2022, K9 "Asco" alerted to the odor of a narcotics emitting from a black Ford Fusion Alabama tag# This vehicle was identified as belonging to Correctional Officer Ashante Patrick (Officer Patrick). Upon Inspector Steven Lee (Inspector Lee) gaining a written consent to search form signed, a search of the vehicle was conducted. Captain Chadd Peddie (Captain Peddie) was conducting a search of the back seat area of this vehicle when Inspector Lee was notified of a recovered package. This package was approximately 7 inches in length and wrapped in a brown masking tape. Officer Patrick was present at this search and indicated it was not her package. Upon opening the package approximately twenty (20) cigarettes were located inside of this package. The manner in which these items were wrapped were indictive with packaging for introduction of contraband into a correctional institution.

Inspector Lee requested K9 officers to search the food service area where Officer Patrick was observed exiting prior to the vehicle search. This is the assigned work area of Officer Patrick. Officer Patrick had arrived at NWFRC at 10:45 a.m. on this date for her assigned shift. Upon K9 conducting a search of the officer's station, K9 "Asco" alerted to the personal bag of Officer Patrick. Located inside of this bag was a second brown masking tape wrapped package. Upon Inspector Lee opening this package, two plastic baggies were observed which contained a green leafy substance, which field tested positive for marijuana. The total weight of these baggies were 54.2 grams.

Officer Patrick was unable to explain the exact same packaging of these two items. With the first item being found outside of the institution, inside of her personally owned vehicle. The second package being found inside of the institution inside of her personally owned bag.

Officer Patrick is observed on fixed wing video entering the institution with the same personally owned bag.

Your Affiant respectfully submits that probable cause has been established that Ashante Sharice Patrick did commit the criminal violation of introduction of contraband into a state institution to wit-controlled substances, in violation of 944.47(1)(a)(4), Fla. Stat., and Felony Possession of a Controlled Substance (Cannabis) 893.13(6)(a) inside the secure perimeter of NWFRC in Washington County, FL. Your Affiant further request an arrest warrant be issued for Ashante Sharice Patrick B/F DOB for a violation of introduction of contraband into a state institution to wit-controlled substances, in violation of 944.47(1)(a)(4), Fla. Stat., and Felony Possession of a Controlled Substance (Cannabis) in violation of 893.13(6)(a). Fla Stat.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
