The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following Violation of the law:
 On the 23rd day of October 2022, at 11:40 AM PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector Alfred Hughes with the Office of Inspector General for the Florida Department of Corrections (FDC). The Defendant is Visitor Lamonteria Johnson (*Visitor Johnson*). Your Affiant has investigated Possession of a Controlled Substance (*MDMA/Ecstasy*) while Visitor Johnson was at Columbia Correctional Institution – (CCI) to visit Inmate Robert Smith (*Inmate Smith*) DC#G01034 at the Annex.

On October 23, 2022, your Affiant was at CCI conducting a planned checkpoint operation to deter the introduction of contraband into CCI. Lead Senior Inspector Chris McGauley (*LSI McGauley*) was also present. FDC Contraband Interdiction Unit (CIU) K-9 and security staff assisted your Affiant with the operation.

Visitor Johnson arrived at CCI at approximately 11:30 am for visitation. Visitor Johnson was a passenger in a 2022 Dodge Challenger, black in color, with a Florida Tag#GHVS06. FDC CIU Correctional Officer Captain James Godwin (*Captain Godwin*) walked his K9 "Rowdy" around the vehicle to conduct a free air sniff. Captain Godwin indicated to your Affiant that a positive alert was displayed to the presence or odor of narcotics.

Your Affiant asked the driver/owner, Raymond Hendon (*Mr. Hendon*), for permission to search his vehicle and its contents. Your Affiant positively identified Visitor Johnson by her Florida Identification Card #J525-526-93-691-0. Your Affiant positively identified Mr. Hendon by his Florida Driver's License #H535-737-90-324-0. Mr. Hendon agreed to the search and signed a Form DC1-804 Consent to Search at approximately 11:40 am. Your Affiant was present and observed the search. Captain Purdue and Correctional Officer Major Brett Handley (*Major Handley*) assisted your Affiant with the search. At approximately 11:44 am, Captain Purdue searched a black in color purse that Visitor Johnson claimed was hers, while Visitor Johnson and your Affiant

watched. Captain Purdue discovered two (2), green in color, square in shape, pills in a brown wallet. Captain Purdue discovered two and a half (2 ½) matching pills in the purse. The pills field tested positive for MDMA.



Visitor Johnson was escorted into the Inspector's Office. At approximately 12:00 pm, Visitor Johnson removed two (2) packages from her Anal Area without being asked and with no warning. One package was wrapped in an orange balloon, cellophane, and black tape. The other package was wrapped in a red balloon, cellophane, and black tape. When opened, both packages contained cigarettes (*rolling papers around tobacco*). The total combined total package weight (TPW) was 33.5 Grams.

Your Affiant conducted a recorded, sworn, post-Miranda interview of Visitor Johnson and noted the following: Visitor Johnson signed the Miranda Waiver Form DC1-848 after it was read to her.

Correctional Officer Sergeant Nancy Spitzer (*Sergeant Spitzer*) escorted Visitor Johnson to the bathroom in the Inspector's Office. Sergeant Spitzer observed something yellow in color under the white in color dress top Visitor Johnson was wearing. At approximately 2:00 pm, Sergeant Spitzer had Visitor Johnson take the yellow in color object out and hand it to her (*Sergeant Spitzer*). Sergeant Spitzer immediately turned the yellow in color object over to your Affiant, at approximately 2:01 pm. The object was wrapped in yellow tape and clear cellophane and had a TPW of 20.3 grams. The white powdery substance in the package field tested positive for MDPV – Methyone (*Synthetic Cathinones*).

Your Affiant respectfully submits probable cause has been established to conclude Lamonteria Johnson did commit the criminal offense of Possession of a Controlled Substance (*MDMA/Ecstasy*) which is in violation of Florida Statute 893.13(6)(a) and Trafficking in Phenethylamines which is violation of Florida Statute 893.135(1)(k)(1)(a) and Two (2) counts of Introduction of Contraband (*Conspiracy*) which is in violation of Florida Statute 944.47(1)(a)(4) / 777.04(3) at Columbia Correctional Institution located in Columbia County, Florida on October 23, 2022.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
