84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Senior Law Enforcement Inspector Steven Lee (SI Lee) of the Florida Department of Corrections, Office of the Inspector General.

Your Affiant has probable cause to believe Nicole Celeste Martin (Ms. Martin) a registered visitor, did commit the criminal offenses of Introduction of Contraband into a state institution, to wit Methamphetamine (99 grams) in violation of FS 944.47(1)(a)(4). Trafficking in Methamphetamine in violation of FS 893.135(1)(f)(1) to wit (99 grams of Methamphetamine). Possession of Suboxone without a prescription in violation of FS. 893.13(6)(a) into Holmes Correctional Institution (Holmes CI), a state prison operated by the Florida Department of Corrections in Washington County Florida.

On March 11, 2023, SI Lee along with Correctional Officer Captain JT Mann (Captain Mann) and Correctional Officer Captain Dustin Jordan (Captain Jordan) were conducting a K9 operation in the parking lot of Holmes CI. Captain Jordan notified SI Lee that K9 "Judd" had alerted to a white Nissan SUV. SI Lee made contact with the vehicle owner and driver Ms. Martin. A consent to search form was obtained and signed by Ms. Martin.

During the search of the vehicle, Captain Mann located two packages wrapped in black electrical tape. These packages are commonly found in the introduction of contraband into a correctional institution. Both packages were located inside the center console along with numerous plastic baggies. Upon questioning Ms. Martin about the items, Ms. Martin

Ms. Martin was escorted to an office by a female correctional officer, where she voluntarily removed another black taped package from inside of her pants. Ms. Martin had made entry into the secure perimeter of Holmes CI with the package prior to the K9 alert.

All three (3) packages were field tested showing a positive alert of Methamphetamines totaling 99 grams. Also located inside of the packages were forty (40) Suboxone strips. Ms. Martin refused to provide a post-Miranda statement and was placed under arrest and transported to Holmes County Jail by the Holmes County Sheriff Department.

All items were collected and preserved in the Region 1 Evidence storage locker.

Your Affiant respectfully submits that probable cause has been established that Nicole Celeste Martin did commit the criminal violations of Introduction of Contraband into a state institution in violation of FS. 944.47(1)(a)(4), Fla. Stat., by introducing Methamphetamine, a stimulant into the secure perimeter of Holmes Cl., Trafficking in Methamphetamin by being in possession of 99 grams of Methamphetamine, and Possession of Suboxone without a prescription by possessing 40 Suboxone strips without a prescription.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
