On March 12, 2023, at approximately 3:14 am, Correctional called for assistance in A dormitory due to Inmate Grimace masturbating while sitting on a toilet in the inmate bathroom while looking at Correctional responded and when he entered the dormitory, Inmate Grimace was still in the bathroom area. informed Inmate Grimace he was being issued a Disciplinary Report (DR) for Lewd and Lascivious Exhibition and proceeded to the rear portion of the bathroom toward Inmate Grimace. While in the bathroom, ordered Inmate Grimace to turn around and submit to hand restraints. Inmate Grimace refused to cooperate nor submit to hand restraints causing to retrieve his chemical agent. Upon administering the chemical agent, Inmate Grimace began to physically fight by striking with numerous hand and fist strikes to multiple areas attempted to assist of his torso and head area. and was exposed to chemical agent which limited her ability to physically apply hand restraints. During the altercation, Inmate Grimace took chemical agent canister and began spraying the chemical agent toward and called for assistance.
